

FACTS	WHAT DOES PREMIER COMMISSION DO WITH YOUR PERSONAL INFORMATION?
WHY?	Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
WHAT?	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> • Social Security number and income • Banking Information • Background information • Contact Information <p>When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.</p>
HOW?	All financial and nonfinancial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Premier Commission chooses to share; and whether you can limit this sharing.

Affiliates	Companies related by common ownership or control. They can be financial or nonfinancial companies.
Nonaffiliated companies	Companies not related by common ownership or control. They can be financial and nonfinancial companies.
Joint marketing	A formal agreement between companies that together market products or services to you.
